1. Membership

- 1.1. By completing the Eynesbury Golf Membership Application, the member agrees to be bound by these terms and conditions. Upon the Membership Application being approved (see 1.6 below of these terms and conditions) or an invoice being issued by Eynesbury Golf, the member must pay the membership fee in full either via EFT or a credit card (as noted on the Membership Application Form).
- 1.2. The membership year is from February 1 to January 31 and is valid for 12 months. At the expiry of the membership period, Eynesbury Golf will issue an invoice for the next annual membership, and until such time as the member pays the invoice in full the membership will not be valid to commence.
- 1.3. Prices current as of 1 January 2021. Rates will be reviewed annually and any increase is not limited to CPI.
- 1.4. Eynesbury Golf Club Membership is non-transferable. Lending, sharing or transferring the benefits of the membership (or the physical membership card) is considered a breach of membership and will result in the immediate cancellation of membership without refund.
- 1.5. The member must accurately complete the Membership Application which is available on the website, at Eynesbury Golf Pro-Shop or you can phone the Golf Pro-Shop to obtain a copy. The member is aware that the information collected will be used for the purposes of processing the Application, and also to communicate with members in relation to golf events and general Eynesbury township events.
- 1.6. Upon receipt of your Membership Application, Eynesbury Golf will review the information and the application approval process may take up to two (2) weeks. Once the membership has been approved, Eynesbury Golf will send a confirmation email to the member.
- 1.7. Eynesbury Golf reserves the right to refuse a membership application in its absolute discretion without giving reasons.
- 1.8. If the Applicant is under 18 years of age, a parent or guardian must also sign this Application and agrees that as a parent or guardian they are responsible for payment of the annual membership fees.
- 1.9. Members must act in accordance to these terms and conditions, all Eynesbury rules and policies, and any applicable regulations. The failure by the member to do so may result in the automatic cancellation of membership at the sole discretion of Eynesbury management.
- 1.10. All members (and any guests) are to comply with the proper and correct use of all the facilities and shall not wilfully or recklessly tamper, misuse or intentionally interfere with the operation of the Eynesbury Golf.
- 1.11. Members agree to abide by the Dress Code of Eynesbury Golf, which includes (without limitation) neat casual, tailored trousers or shorts; smart denim jeans; golf shoes or sport runners (soft spike preferred).

1.12. Cart Usage:

- (a) All members (and their guests) when using the golf cart, agree to abide by the terms of the cart membership terms and conditions.
 - (b) Cart use is subject to availability and course conditions on the day.
 - (c) A warning will be given for the first breach of the cart membership terms and conditions. A second warning may result in the membership being terminated by Eynesbury Golf.
 - (d) Non-cart members must pay \$20 to ride in a cart (with a cart member at all times).
- 1.13. All members (and their guests) when using the range agree to abide by the terms of the range membership terms and conditions.
 - 1.14. The member must be present during guest rounds.
 - 1.15. Where a member wishes to amend their membership (to increase their membership benefits only), the amendments must be requested in writing to the Eynesbury Golf General Manager. Only amendments approved in writing by the Eynesbury Golf General Manager will be deemed valid amendments.

A member cannot amend their membership to reduce the membership benefits during the annual membership period.

2. Rules of Play

- 2.1. Tee times are based on availability. Cancellations of tee times must be made 24 hours prior to play. Cancellation penalties may apply.
- 2.2. Members must book and sign-in through the Pro Shop prior to play. All players must register with the Pro Shop prior to play.
- 2.3. Offensive or aggressive behaviour to Eynesbury representatives and other members/guest at the Eynesbury golf facility, will not be tolerated. Members who consume alcohol on the premises are to do so responsibly. Drunkenness will not be tolerated. Members who breach the behaviour code of conduct may have their membership cancelled without refund.
- 2.4. Management reserves the right to restrict access to the golf course for private hire or other events.

3. Cancellations, Refunds and/or Extensions

- 3.1. No refunds or extensions apply on memberships (exception those described in 2.2 below in these Terms and Conditions).
- 3.2. Members of a 7-day; 6-day; Corporate; Intermediate; and Midweek membership may apply in writing to the General Manager for an absentee status for a minimum period of 3 months which is subject to approval by the General Manager. If approval is granted an extension will apply for the period of the absentee period. Playing rights and member privileges are suspended during this time Members accept decisions made by the General Manager of Eynesbury Golf or his designate are final.
- 3.3. If a notice of cancellation is stated to be effective prior to 31st December in any year, the member shall not be entitled to any refund of fees or subscriptions paid. Members paying monthly are committed to all 12-payments in a calendar year.
- 3.4. Any competition winnings must be spent prior to membership expiry date or cancellation, otherwise the competition winnings will be forfeited.
- 3.5. If a member ceases to be a member for any reason (including as a result of disciplinary action) shall not be entitled to any refund of any subscription or fee paid in advance, unless otherwise determined by the General Manager.

4. Amendment of these Terms and Conditions

- 4.1. These terms and conditions (or part thereof) may be varied, amended or terminated from time to time.
- 4.2. Where the terms and conditions are materially amended or terminated, written notice will be provided to the member from the General Manager of the Eynesbury Golf.

5. General Conditions, Exclusions and Limitations

- 5.1. Eynesbury Golf will not be liable for any failure or delay in providing any of the benefits or reassures of the membership, either in whole or in part.
- 5.2. To the extent permitted by law, Eynesbury Golf will not be liable to any person or any indirect, special or consequential loss or damage in connection with the membership or utilisation or redemption of any membership benefits or features, whether in contract, tort (including negligence), statute or otherwise.
- 5.3. Should Eynesbury Golf incur any liability to any person for any loss in connection with the membership or utilisation or redemption of any membership benefit or feature, that liability will be limited to the annual membership fee.
- 5.4. Any prices quoted are inclusive of GST and are in Australian dollars.
