



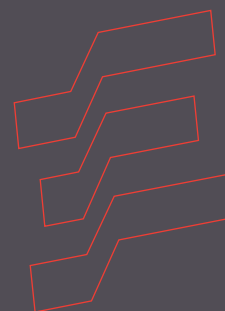

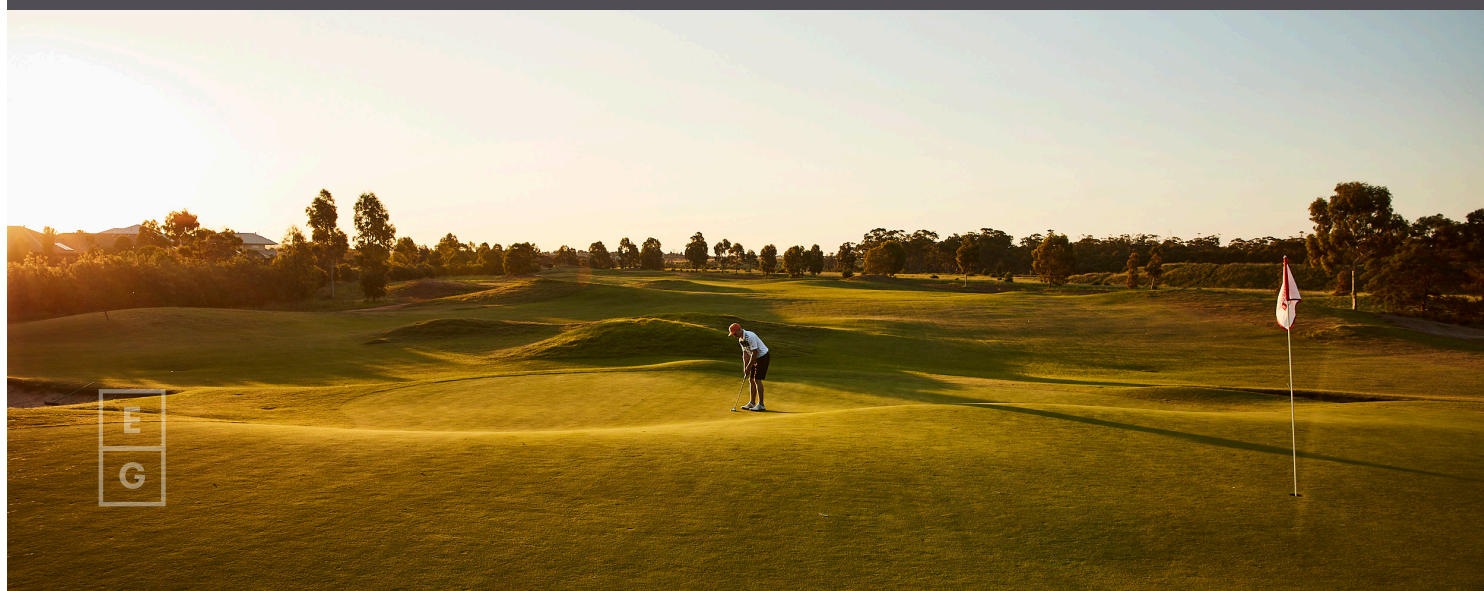

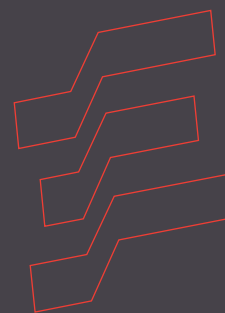

- 1.3. Open to women with or without a current golf handicap can apply. You can attain a golf handicap through this membership.

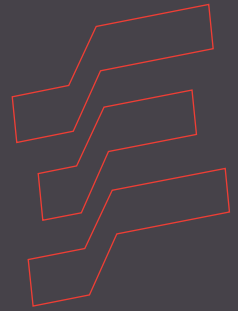

Membership Benefits & Cart Rates



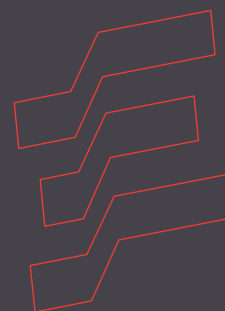
- All Membership categories give a 10% discount **on all goods sold in the proshop.**
- **Spouse membership:** Second household member will be offered a **50% discount on their membership.** The discount cannot apply to a higher membership category than your spouse and cannot be used to discount the Women's Pathway Membership or Corporate Memberships.
- As a member you will receive a discounted cart rate of:
 - \$30 for 18 holes (\$15 to share)
 - \$20 for 9 Holes (\$10 to share)
 - Members aged 65+ flat rate of \$20 (\$10 to share)

Flexi Membership

Categories & Conditions



Upon signing up, members receive a points balance, giving you the chance to book rounds in at your convenience, with points deducted for each round you play.

Choose between two membership tiers.



Silver Tier Priced at \$500

This level grants you an initial 400 points to start your golfing journey.



Gold Tier Priced at \$1100

Enjoy a substantial 1000 points along with the added bonus of a Golf Australia handicap, giving you a competitive edge on the greens.

1.1 Flexi Memberships must be paid upfront and in full.

1.2 Any current Flexi members with leftover points from their 2025 membership will retain their points should they continue their Flexi membership in 2026 with the above fees applicable.

1.3 Flexi members wishing to upgrade their membership to a higher category, can also have their residual points credited towards their membership upgrade.

Eg: If you have 16 points remaining, which is a value of \$80, this \$80 will be taken off your membership.

Cart Waiver Form

Purpose

This policy applies to all members and visitors who bring and use privately owned golf carts on the Eynesbury Golf Course and associated private property. Use of a private golf cart is permitted only where this policy is read, understood, and signed.

1. Operator Responsibility

1. Operator Responsibility

The operator is solely responsible for the safe operation, control, and condition of their private golf cart at all times. Use of a private golf cart is undertaken entirely at the operator's own risk.

2. Compliance with Laws, Road Rules & Insurance

The operator is solely responsible for ensuring compliance with all applicable Victorian laws, road rules, legal requirements, and insurance obligations relevant to the use of their privately owned golf cart. This includes determining whether registration, licensing, or insurance is required in any circumstance. Eynesbury Golf does not provide advice, approval, or confirmation regarding road legality, registration status, or insurance coverage and accepts no responsibility for any non-compliance by the operator.

3. Vehicle Condition & Approval

Golf carts must be well-maintained, safe, and free from defects. Eynesbury Golf reserves the right, at its sole discretion, to refuse access or withdraw permission for any private golf cart deemed unsafe, unsuitable, or non-compliant.

4. Operating & Safety Rules

Golf carts must be operated in a safe, courteous, and controlled manner at all times. Speed must be appropriate for conditions and must not exceed any limits set by Eynesbury Golf. Carts must remain within permitted areas only. Reckless, unsafe, or inappropriate operation will result in immediate withdrawal of permission to use a private golf cart.

5. Insurance, Liability & Indemnity

The operator is responsible for all insurance relating to their private golf cart, including loss, damage, and third-party liability. Eynesbury Golf accepts no responsibility or liability for injury to the operator or any third party, damage to property, or loss of or damage to privately owned golf carts. The operator releases and indemnifies Eynesbury Golf, its owners, employees, contractors, and agents from all claims, losses, damages, costs, or expenses arising from the use of a privately owned golf cart, except to the extent required by law.

6. Safety Check – Staff Verification

Prior to use, an Eynesbury Golf staff member may complete a basic visual safety check. This check is limited in scope, does not constitute certification or approval, and does not transfer any liability to Eynesbury Golf.

7. Acknowledgment & Agreement

By signing below, I acknowledge that I have read and understood this policy, accept full responsibility for the operation, condition, and legal compliance of my private golf cart, understand that Eynesbury Golf does not provide insurance coverage for privately owned golf carts, and acknowledge that all liability arising from the use of my private golf cart rests with me and not Eynesbury Golf.

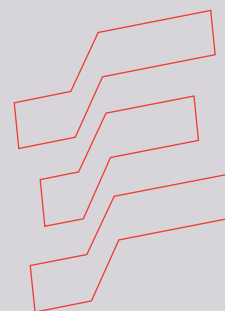
